In favor of the State of Mississippi, Department of Wildlife, Fisheries and Parks, Office of Parks and Recreation (Releasee).

I, Releasor, being of lawful age and in consideration of being permitted to participate in Off Road Vehicle Trails (ORV) trail usage in designated areas of Trace State Park, do for myself, my heirs, executors, administrators, assigns and successors in interest, hereby release and forever discharge the State of Mississippi, Department of Wildlife, Fisheries and Parks, Office of Parks and Recreation, its heirs, administrators, executors, and successors in interest of and from any and every claim, demand, action or right of action, of whatever kind of nature, either in law or in equity, arising from or by reason of any bodily injury or personal injuries known or unknown, death or property damage resulting or to result from any accident which may occur as a result of Releasor's participation in ORV trail usage, or any activity or activities in connection with ORV use, at or on any part of Trace State Park, whether as the result of negligence on the part of the Releasee or not.

I further release all employees, officers, independent contractors, or other agents of the Releasee, professionals, guest or other persons, from any claims whatsoever on account of first aid, treatment or other services rendered to me during my participation in ORV trail usage at the above named state park, its environs and surrounds.

The Mississippi Department of Wildlife, Fisheries, and Parks or its employees shall owe no duty of care to keep the premises safe for entry or use by others for recreational activities or to give warning of any hazardous condition, use structure or activity on the premises to person entering for those purposes. Given the permission to pursue recreational activities on the premises shall not thereby:

- A. Extend any assurance the premises are safe for those purposes.
- B. Make the person to whom permission is granted an invitee or licensee to whom a duty of care is owed; or
- C. Assume responsibility for or incur liability for any injury to person or property caused by any act of persons to whom the permission is granted.

This release contains the entire agreement between the parties hereto and the terms of this release are contractual and not a mere recital.

The Releasor further states, avers and affirms that he/she has carefully read the foregoing and knows the contents thereof and has signed this release as his or her own free act.

**Off Road Vehicle (ORV) Trail Usage**

Riders must register at the Park Office before riding trails (drivers license may be required for identification).

Riders must be in possession (on person) of a permit while riding trails at Trace State Park.

Riders shall avoid any areas or actions whenever his/her activities might cause danger to property, person or other persons/property.

Any incidents resulting in personal injury or damages to persons, property, or PARK property must be reported to the Park Manager or other Park Official in written form.

The permit may be terminated by Park Officials/Officers upon notification to the rider. No refunds are granted.

Minor riders (ages 7 to 20 ) must be accompanied by an adult (age 21+). Minor Release Waiver must be completed by parent or legal guardian and on file. Minors age 6 and under are not permitted.

Safety equipment is required at all times while ORV is in operation.

The Mississippi Department of Wildlife, Fisheries, and Parks or its employees shall owe no duty of care to keep the premises safe for entry or use by others for recreational activities or to give warning of any hazardous condition, use structure or activity on the premises to person entering for those purposes. Given the permission to pursue recreational activities on the premises shall not thereby:

- A. Extend any assurance that the premises are safe for those purposes.
- B. Make the person to whom permission is granted an invitee or licensee to whom a duty of care is owed; or
