## **MINUTES OF THE MEETING**

**PRESENT:** Commission Chairman Charles Rigdon, Commissioners William "Billy" Deviney, Clay Wagner, Bill F. Cossar, and Scott Coopwood.

Among the MDWFP staff attending were: Dr. Sam Polles, Executive Director; Robert Cook, Deputy Executive Director; Larry Castle, Michael Bolden, Jennifer Head, Larry Pugh, Chad Dacus, Colonel Steve Adcock, Jason Thompson, and counsel, Drew Malone, Special Assistant Attorney General.

Chairman Rigdon gaveled the meeting to order and welcomed future Commissioner, Robert Taylor, to the meeting.

## **OPENING PRAYER**

Larry Castle, Director of Technical Programs, opened the meeting with prayer.

## **MINUTES**

ACTION: Upon motion by Commissioner Deviney and seconded by Commissioner Cossar, the February 22, 2016 Commission meeting minutes were unanimously approved.

## **AGENDA**

The Commission was informed of two additional requests for the March 16, 2016 agenda:

- Under "Other Business" Moon Lake Temporary "No-Wake Zone" Order.

ACTION: Upon motion by Commissioner Deviney and seconded by Commissioner Cossar, the agenda for March 16, 2016 was unanimously approved as amended.

## **PUBLIC COMMENTS**

Two gentlemen came before the Commission with comments.

• Dr. Kary G. Whitehead, Meridian, MS, presented a handout to the Commission concerning problems with dog hunters running dogs on his property located in Kemper County.

The Commission informed Dr. Whitehead that his best recourse would be to join forces with other landowners experiencing this problem and petition the Legislature for changes.

Mr. Randall Livingston, Louisville, MS, brought a rabbit hunting concern to the Commission.
Rabbit hunters are expected to wait until after deer season, which is February, to hunt;
therefore. Mr. Livingston requested for deer season to end shortly after New Year's Day
allowing more time for rabbit hunters.

The Commission thanked Mr. Livingston for coming.

## **LICENSE SALES REPORT**

Jason Thompson, Director of License/Boat Registration, presented the License Sales Report for the month of February 2016. Total revenues were only down less than one percent.

Highlights of Thompson's report are listed below:

- Resident License Sales down 2%.
- Senior Exempt Licenses up 7%
- Small Game up 5%
- Range permits up 10%
- Non-resident sales down less than 1%
- Freshwater Annual licenses up 6%
- Three day Freshwater licenses up 9%
- One day Freshwater licenses up 6%
- Lifetime License category up for the first time this year

# FINAL 40 Miss. Admin. Code Part 3, Rule 2.1 – State Fishing Lakes and Community Assistance Program Lakes

Rule 2.1 – Regulations Regarding State Fishing Lakes

Larry Bull, Assistant Director of Fisheries Bureau, presented the FINAL version of the rule, with no changes from the proposed version adopted last month. No comments were received.

ACTION: By motion of Commissioner Cossar and seconded by Commissioner Deviney, Rule 2.1 was approved unanimously by the Commission as presented.

# FINAL 40 Miss. Admin. Code Part 2, Rule 8.5 - Regulations Regarding Animals in Captivity and Enclosures

## Rule 8.5 – Decommission of Enclosures containing White-tailed Deer

Chad Dacus, Director of Wildlife Bureau, recommended adoption. No changes were made since the last meeting and no comments were received.

ACTION: By motion of Commissioner Cossar and seconded by Commissioner Coopwood, Rule 8.5 was approved unanimously by the Commission as presented.

## PROPOSED 40 Miss. Admin. Code, Part 2, Chapter 5 – Alligator

Ricky Flynt, Wildlife Alligator/Furbearer Coordinator, presented PROPOSED rule changes listed below:

## Rule 5.1 – Alligator General Regulations

- Further defines alligator wrestling activity.
- Adds harassment of alligators as an illegal act.
- Increases alligator ranch license fee from \$50 to \$100.
- Adds requirements to be approved for alligator egg producing facility permits.
- Clarifies that CITES tags are not required for sale of live hatchlings.

## Rule 5.2 – Private Lands Alligator

- Opens 12:00 noon August 26 and ends 6 a.m. September 19, 2016
- Adds Lowndes, Noxubee, and Oktibbeha Counties to open counties list (total of 31 counties)

## Rule 5.3 – Public Waters Alligator

- Opens 12:00 noon August 26 and ends 12:00 noon September 5 (Labor Day), 2016
- Further clarifies closed portion of Ross Barnett Reservoir
- Change "First-come, First-serve" permit purchase date from 2<sup>nd</sup> Tuesday in July to 3<sup>rd</sup> Tuesday in July

#### Permit Allocation Changes

- No changes to the Seven (7) Zones or their boundaries
- No net change to total permits issued (920).
- Permits per zone redistributed as follows:

Zone 1 – Northwest 100 50

Zone 2 – Northeast 150

Zone 3 – West Central <del>150</del>–170

Zone 4 - Southwest <del>150</del>-170

Zone 5 - South Central 150

Zone 6 – Southeast 150

Zone 7 – Pearl/Ross Barnett 70 80

ACTION: By motion of Commissioner Cossar and seconded by Commissioner Coopwood, the proposed amended Rules 5.1, 5.2, and 5.3 were approved unanimously by the Commission as presented.

## FINAL 40 Miss. Admin. Code Part 6, Rule 1.1 – State Park Fees

Rule 1.1 – State Park Fees FINAL

Jennifer Head, Director of State Parks, recommended approval. No comments were received, and the rule was presented as a FINAL version with no changes from the proposed version adopted last month.

ACTION: By motion of Commissioner Cossar and seconded by Commissioner Coopwood, Rule 1.1 was approved unanimously by the Commission as presented.

## **Citation Report**

Colonel Steve Adcock, Chief of Law Enforcement, presented a handout which highlighted violations, shooting range attendance, and flood details along the Mississippi River (including 36 rescues).

## **License Reinstatement Request**

Colonel Adcock stated that the violator had taken his Hunter Education class and paid his fines. Adcock asked Saxton to come forward and state the circumstances of his arrest before the Commission.

Barry Clark Saxton, Benton, MS
 Saxton was convicted of headlighting in December 2014. He and some friends decided to go road hunting and fired four or five shots from the truck. He paid \$3,900 in fines and spent the night in jail.

ACTION: By motion of Commissioner Cossar and seconded by Commissioner Deviney, Saxton's reinstatement was unanimously approved by the Commission.
