EDUCATIONAL SESSION – 2 PM

PRESENT: Commission Chairman William "Billy" Deviney, Commissioners Bill F. Cossar, Clay Wagner, Scott Coopwood, and Robert Taylor.

Among the MDWFP staff attending were: Dr. Sam Polles, Executive Director; Robert Cook, Deputy Executive Director; Michael Bolden, Larry Castle, Colonel Steve Adcock, Russ Walsh, Jennifer Head, Jason Thompson, and counsel, Drew Malone, Special Assistant Attorney General.

Three items were on the agenda for the Educational Session. PowerPoint presentations were presented for all three items.

1. Law Enforcement.

Colonel Adcock's presentation featured the current number of visitors to the ranges at Turcotte and McHenry; revenue and expenditures; and an update on the progress of construction of the new McIvor Creek facility.

Captain Reed updated the Commission on the progress of the current class of conservation officer cadets in their training. Captain Reed also gave a brief update of the ongoing development of the facilities at the Mississippi Conservation Officers Training Academy ("MCOTA").

2. WMA & State Parks Forestry Management Reports.

Scott Baker, WMA Habitat Program Coordinator, presented WMA Forestry Report. Carl Branson, Forester, presented State Parks Forestry Report.

Mr. Baker and Mr. Branson presented reports detailing amount of timber cut and revenue produced. The Commission was also updated on management practices designed to improve wildlife habitat and the natural character of agency WMAs and Parks.

3. Turkey Survey Results.

Rush Walsh, Director of Wildlife Bureau, presented results of on-line turkey survey. The report detailed the process of preparing the survey and the data produced. Overall, no substantial changes in wild turkey management are anticipated in the near future.

<u>MINUTES OF THE BUSINESS SESSION – 3 PM</u>

PRESENT: Commission Chairman William "Billy" Deviney, Commissioners Bill F. Cossar, Clay Wagner, Scott Coopwood, and Robert Taylor.

Among the MDWFP staff attending were: Dr. Sam Polles, Executive Director; Robert Cook, Deputy Executive Director; Michael Bolden, Larry Castle, Colonel Steve Adcock, Larry Bull, Russ Walsh, Jennifer Head, Jason Thompson, and counsel, Drew Malone, Special Assistant Attorney General.

Chairman Deviney, having noted for the minutes that a quorum was present, gaveled the meeting to order at 3 p.m. Chairman Deviney welcomed Scott Bounds, Chairman of Wildlife, Fisheries, and Parks Committee of the House of Representatives.

OPENING PRAYER

Robert Cook, Deputy Executive Director, opened the meeting with prayer.

EXECUTIVE SESSION

In an effort to advance a full agenda, the Chairman asked if there was a need for an Executive Session. The Executive Director stated that there was need for an Executive Session to discuss transactions in land, and personnel matters, and possible litigation.

ACTION: Commissioner Wagner made a motion to close the meeting to determine the need for Executive Session to discuss transactions in land, personnel matters involving job performance of individuals in specific positions as well as budget line items which could affect the continued employment of individuals in specific positions, and strategy for potential litigation. Commissioner Cossar seconded the motion and the Commission voted unanimously to close the meeting.

Counsel announced to those present that the meeting was now closed to determine the need for Executive Session to discuss transactions in land, personnel matters involving job performance of individuals in specific positions as well as budget line items which could affect the continued employment of individuals in specific positions, and strategy for potential litigation. As a convenience to those who had just arrived and taken seats in the conference room, the Commission left the room and entered an anteroom for the closed meeting discussion.

A brief discussion followed.

ACTION: Upon a motion made by Commissioner Wagner, and seconded by Commissioner Cossar, the Commission voted unanimously to enter Executive Session to discuss transactions in land, personnel matters involving job performance of individuals in specific positions as well as budget line items which could affect the continued employment of individuals in specific positions, and strategy for potential litigation.

Counsel returned to the conference room and announced to those inside, that the Commission had entered Executive Session to discuss transactions in land, personnel matters involving job performance of individuals in specific positions as well as budget line items which could affect the continued employment of individuals in specific positions, and strategy for potential litigation.

Executive Director Dr. Sam Polles and Deputy Executive Director Robert Cook updated the Commission on the authorized realignment for the agency's wildlife/fisheries biologist series. They advised that the realignment was set forth and prescribed in the legislative notes of the agency's appropriation bill for fiscal year 2018 and will take effect on and after July 1, 2017.

Discussion followed regarding several specific employees who would be affected by the proposed realignment.

No action was required of the Commission.

Dr. Polles also advised the Commission of potential difficulties with language in the current RFP which may prohibit the Agency from awarding a contract to any independent vendor, firm, or entity for the production of the Mississippi Outdoors television show at this time. This could result in the cancellation of the RFP.

Discussion followed.

No action was required of the Commission.

Finally, Dr. Polles updated the Commission on the status of discussions with parties of interest in the operations of the Calhoun County WMA, including MDWFP, Forest Investment Associates, TimberCorp, and two representatives of the Calhoun County Board of Supervisors. The landowner has contacted the agency about a possible hike in rent. At issue is the question of maintaining the roads within the leased lands. There is a tentative plan in the works which could result in a reduction in the increase in rent and improved access to the WMA by working with the Board of Supervisors to address the roads. The Calhoun County Board of Supervisors will be contacting the Yalobusha County Board of Supervisors concerning this plan for road maintenance. The landowner agreed to give a 45-day extension to MDWFP and no changes would be made in the contract until August 14, 2017.

Discussion followed.

No action was required of the Commission.

ACTION: There being no further items for confidential discussion, Commissioner Wagner moved to end Executive Session and return to the open meeting. Commissioner Cossar seconded the motion, and the Commission voted unanimously to end Executive Session.

As the Commission returned to the conference room, Counsel announced that the Commission had discussed the items set forth earlier for executive discussion; however, as no action was required of the Commission, no votes had been taken.

The Chairman returned to the regular Business Session Agenda.

MINUTES

ACTION: Upon motion by Commissioner Cossar and seconded by Commissioner Wagner, the minutes of the May 17, 2017 meeting were unanimously approved.

<u>AGENDA</u>

ACTION: Commissioner Wagner moved to approve the agenda for June 14, 2017. Commissioner Cossar seconded the motion and the motion carried.

PUBLIC COMMENTS

Phil Lechner had made an appeal to the Commission at the May 17, 2017 meeting to change deer regulations for Leaf River Wildlife Management Area. Lechner brought Mr. Mark Sramek and Mr. Eric Oehms with him to the June 14, 2017 meeting. Lechner said he had many calls from people concerned with the deer regulations but apologized that he did not have any names or comments in writing. He asked the Commission to postpone his comments until after the MDWFP biologist presented his findings.

Larry Castle, Director of Technical Programs, informed the Commission that the deer regulation changes were strictly a hunter preference and will not have a negative biological impact on the deer. On a positive note, the changes will mean larger bucks next year with the payback of reduced hunting for bucks this year. Castle stated that MDWFP will poll deer hunters at the end of next year's deer season and the results will be taken into consideration by the Commission for any future changes in regulations.

Mr. Lechner did not have any further comments.

No action was taken by the Commission.

PARKS

FINAL Rule- 40 Miss. Admin. Code Part 6, Chapter 1 – General Regulations

Rule 1.1 – State Park Fees

Jennifer Head, Director of Parks, stated that no comments had been received concerning the fee adjustments to Mallard Point Golf Course and disclaimers which were added to the regulations.

Captain Chris Reed presented the six-man Conservation Officer team that claimed the title "Fittest in the Nation" as they took the top spot at the 16th annual National LawFit Challenge held this past weekend in Pearl, MS. Over 135 law enforcement officers from around the country competed in this year's event which tests officers in six different events: bench press, 1.5 mile run, sit-ups, flexibility, pull-ups, and a suspect pursuit course.

The following records were broken by Team MDWFP:

- New record for points scored by a four-man team with 1618 points scored. (Scott, Christon, Gates, Reed)
- 2. Two-man team record 846 points (Scott, Christon)
- New Individual record set 424 points (Scott)
- 4. Individual record 422 points (Christon he broke his own previous individual record of 418 set in 2015)
- 5. Bench Press record lifting 226% of his bodyweight (Gates)
- 6. Gates scored 407 points (5th highest point total ever)

A standing ovation followed as a William C. "Billy" Deviney Wildlife Management Area road sign was revealed.

Chairman Deviney presented a video presentation highlighting the strides and achievements of MDWFP over the past 15 years and his many thanks working alongside the other Commissioners and staff, with special thanks to agency Executive Director Dr. Sam Polles.

Another round of applause followed thanking Chairman Deviney for the many years of contribution to the Department and to Mississippi's natural resources.
