RESOLUTION

Dr. Sam Polles, Executive Director, explained that a Special Meeting of the Commission had been called in order to consider a resolution of the Commission, requesting the issuance of general obligation bonds as provided in House Bill 787 of the 2014 Regular Legislative Session, for repairs and renovation projects at various state parks. The Bond Advisory Division of the Department of Finance and Administration has requested a resolution from the Commission on Wildlife, Fisheries, and Parks stating the need to issue and sell general obligation bonds as provided in HB 787.

After discussion, Commissioner Billy Deviney made a motion for the Commission to approve a Resolution authorizing the State Bond Commission to issue and sell general obligation bonds in an amount not to exceed Two Million, Five Hundred Thousand Dollars (\$2,500,000.00) to fund the State Parks Renovation, Repair, and Capital Improvements Fund of the State Treasury. Commissioner Rigdon seconded the motion and it was unanimously approved. A copy of this Resolution has been appended to the minutes.

Finding of the need for the State Bond Commission to issue general obligation bonds and for related matters.

RESOLUTION

WHEREAS, House Bill 787 of the 2014 Regular Legislative Session was passed into law on or about April 24, 2014;

WHEREAS, Section 36 of HB 787 created the "State Parks Repair, Renovation and Capital Improvements Fund" in the State Treasury, to be used to fund such repairs and renovations as shall be needed in the various state parks;

WHEREAS, Subsection (3)(a) of HB 787 provides that, from time to time, "[u]pon the adoption of a resolution by the Mississippi Commission on Wildlife, Fisheries and Parks, declaring the necessity for the issuance of any part or all of the general obligation bonds authorized by this subsection, the Mississippi Commission on Wildlife, Fisheries and Parks shall deliver a certified copy of its resolution or resolutions to the [State Bond] commission." Upon receipt of this Commission's resolution, the State Bond Commission may issue and sell general obligation bonds as set forth in HB 787;

WHEREAS, The Commission on Wildlife, Fisheries, and Parks has received notice from the Bond Advisory Division of the Department of Finance and Administration of the need to issue and sell general obligation bonds to fund certain projects of renovation and repair, the costs of which are to be paid from the State Parks Repair, Renovation and Capital Improvements Fund; WHEREAS, the Bond Advisory Division has requested a resolution from this Commission stating the need to issue and sell general obligation bonds as provided in HB 787.

THE COMMISSION finds that the request is well-founded and shall be granted.

THEREFORE, pursuant to the authority set forth in HB 787, 2014 Regular Legislative Session, the Commission hereby resolves as follows:

BE IT RESOLVED that the Commission on Wildlife, Fisheries and Parks finds that there is a need to issue and sell State of Mississippi General Obligation Bonds, Series 2015(A) in the total amount of \$154,685,000.00 with Two Million, Five Hundred Thousand Dollars (\$2,500,000.00), to fund the State Parks Renovation, Repair, and Capital Improvements Fund of the State Treasury. By the authority of this resolution as granted in HB 787, the Commission respectfully requests that the State Bond Commission issue and sell such general obligation bonds as shall be needed and per the advice of the Bond Advisory Division of the Department of Finance and Administration.
