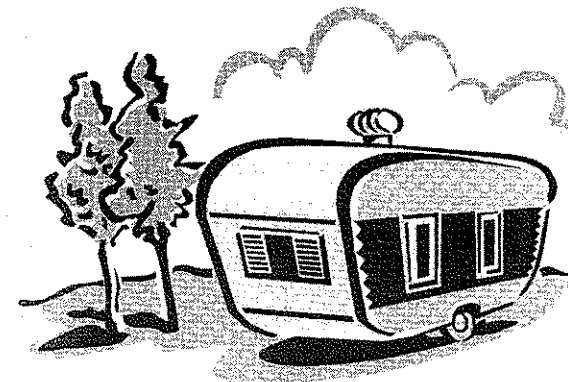


### Refunds

Vouchers may have an expiration date applied per public notice. **Cash refunds are not allowed. No refunds will be granted after check-in or for shortened stays.**

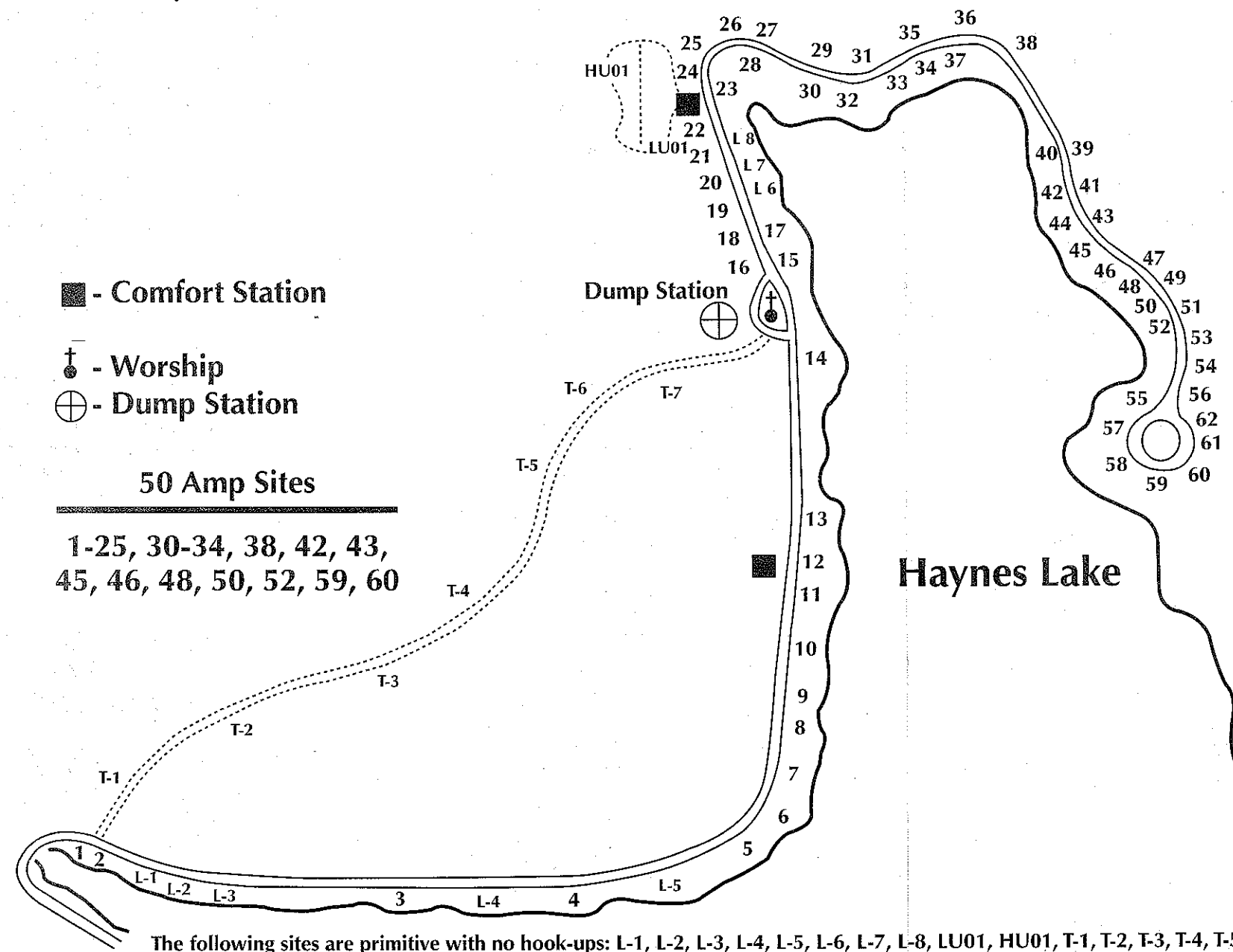

1. ALL CAMPSITES MAY BE RESERVED. Reservations may be made up to 24 months in advance. Full payment is required at the time reservations are made. (Length of stay restrictions may apply).
2. **RESERVATIONS** may be made by contacting the **Park Office** at 662-438-6914; online at [www.mdwfp.com](http://www.mdwfp.com); and/or through Reserve America at 1-800-GO PARKS (464-2757).
3. Campers must be registered prior to setting up on a campsite. This may be done by stopping by or calling the **Park Office**.
4. **CHECK-OUT** time is 2:00 pm - No Exceptions.

### 50 Amp Sites

1-25, 30-34, 38, 42, 43,

The following sites are primitive with no hook-ups: L-1, L-2, L-3, L-4, L-5, L-6, L-7, L-8, LU01, HU01, T-1, T-2, T-3, T-4, T-5, T-6, T-7

5. Check-In time is 4:00pm. All fees payable in advance.
6. Know which site you want prior to calling or making your reservation. The site you choose is the site you will have. Any transfers if available to you shall be subject to a transfer fee.
7. **Unregistered campers, campers not departed by check-out time; vehicles boats, etc., parked on campsites may be removed or towed away from campsites as necessary at owner's expense.**
8. Standard campsites have water and electricity.
9. Please notify the park if you will be arriving after 5PM. Reservations will not be held after 11:00 am on the morning after the scheduled arrival date, and the site may be released to other campers, unless the Park is notified and acceptable arrangements for the late arrival have been made. Both the reservation and the deposit are forfeited.
10. Holidays or Special Events require a 3 night minimum reservation.
11. Camping shall be confined to the designated campground. (No "Back Country" camping).
12. **No ATV's, dirt bikes or non street legal vehicles are permitted on park roads.** Scooters (gas or electric), motorized toys (Barbie Jeep, John Deere Gator, etc.) are not permitted.
13. **Quiet hours are from 10:00pm to 6:00 am.**
14. No more than one camping unit will be allowed on a camp pad without the Park Manager's approval. One additional unit (tent only) may be allowed and charged the primitive rate per night. Maximum occupancy for a campsite shall be no more than two (2) vehicles and eight (8) people, including visitors and overnight guests.
15. Campgrounds are restricted to registered campers and guests only. Guest shall leave the area prior to 10:00 pm.
16. Camping pads shall not be rented to or for any person under the age of 21.
17. Children and pets shall not be left unattended.
18. Camping units should not be left unattended, the park or its staff is not responsible for lost, stolen moved or damaged items.
19. **The washing of vehicles or campers, routine maintenance tasks or repairs to campers, boats or vehicles are prohibited.**
20. Persons with pets shall be required to restrain them on an adequate lease not longer than six (6) feet. **PETS THAT DISTURB OTHER GUESTS SHALL BE REMOVED FROM THE PARK.** Proper disposal of excrement deposited by pets is required.
21. Pets are not allowed in designated swimming areas, cabins or cabin areas. Other restrictions may apply.
22. No person shall sell or offer for sale any merchandise or articles of any type.
23. **Smoking is prohibited in all campground comfort stations/bathhouses.**
24. No person shall operate or use radios, phonographs, or other sound producing equipment in any area of the park which is audible beyond the immediate vicinity so as to disturb other persons.
25. **Alcoholic beverages are prohibited on state park lakes.**
26. **Fireworks are prohibited.**
27. No trot lines, set lines, jug fishing, or commercial gears are allowed.
28. Swimming shall be allowed in designated areas only. **No lake swimming or wading permitted.**
29. Bicycles are permitted but are prohibited from use after dark unless equipped with functioning headlights and reflectors. Cyclists shall not travel State Park roads more than two abreast, and if in large groups, must travel single file.
30. Operation of generators is prohibited without the permission of the Park Manager.
31. Use of metal detectors is prohibited without the written permission of the Executive Director.
32. No person except children six (6) years of age or younger shall use restrooms designated for the opposite sex.
33. **All guest and visitors are subject to entrance/activity fee requirements. No exceptions are permitted.**
34. Gray water and sewage must be placed in the dump station (when provided). In no case is the discharge of gray water or sewage on the ground or campsite permitted nor is the storage of gray water or sewage in containers not manufactured specifically for this purpose. **Violations are subject to criminal charges, fines and/or the cost of the clean up.**
35. **GARBAGE** – Onsite garbage collection is not available. Please place all garbage in the dumpsters provided. **Campsites should be left free and clear of any and all garbage.**
36. No fires are allowed except in designated fire rings. Campfires are permitted pending MS Forestry Commission approval for Tishomingo County.
37. No permanent use of a campground for resident purposes is allowed. "Homesteading" or otherwise using a campground for a sole place of residence is prohibited. The act of Homesteading includes but is not limited to: erecting permanent or semi permanent structures.
38. Special group camping rates are available to Scouts and other non-profit groups. These groups are permitted in designated areas only. Should these groups choose to reside in the primary camping area, they are subject to the same rates and restrictions of any other camper including occupancy restrictions.
39. The Park Manager, or representative may, at his discretion, cause the removal or limit the stay of persons or vehicles causing any disturbance or in any way creating nuisance.
40. **TRANSFERS:** A one time transfer of a reservation may be allowed pending availability and must be made 7 days prior to the date of arrival. A transfer fee of \$10.00 is charged for each unit being transferred.
41. **CANCELLATION POLICY/FEE:** A cancellation fee of \$10 will be charged on reservations cancelled 7 days or more in advance. If cancelled within 0-6 days of arrival **50% of the total amount for the reservation will be forfeited.** All remaining balances, if applicable, shall be placed on a voucher. 42. Rangers live on the park and may be contacted for emergencies or incidents that may arise. During regular business hours, (8am – 5pm) calls may be directed to 662-438-6914. After hours you may contact the Tishomingo County Sheriff 662-423-7000.
43. Please give family and friends your campsite number so that **EMERGENCY** messages may be delivered promptly.
44. Any person renting or reserving a unit may be asked if he/she has a criminal background, pursuant to Miss Code Ann §45-33-49. Any person who is a registered sex offender, who rents or reserves camping/cabin facilities without informing the park of his/her status, may be removed from the park. Any registered sex offender, who does provide the park with notice of his/her status, may be refused access to such facilities.
45. Other rules, regulations and laws may apply as set forth by the State of Mississippi, Tishomingo county and MDWFP.
46. **Disclaimer: Patrons using the facilities at any Park shall be responsible for any loss or damage caused by the patron to such facilities. The MDWFP reserves the right to pursue any legal means, whether civil and/or criminal, to recover its losses or damages.**
