### **Caterer's Regulations:**

- All food, dishes, and utensils are not provided by the VEC.
- Dishes must be prepared before the event and ready to serve.
- Red punch may not be used for refreshment. Light colored punches are allowed.
- Chocolate fountains are not allowed.
- No alcohol is allowed.

### **Decorating Regulations:**

- No nails or tape of any kind will be placed on the walls of the VEC.
- Plastic must be placed under live decorative plants.
- All decorations must be approved.
- No confetti, tinsel, glitter, or smoke machines are allowed.
- No open flames of any kind are permitted in the VEC.
- All litter is to be placed in proper receptacles.
- A period of 2 hours is allowed before said time for both catering/decorating purposes.
- The VEC is a smoke-free facility.

### Clean-up:

- All garbage will be bagged and deposited in the trash container.
- Exactly 1 hour is allowed after the event for clean-up.

### **Payment Policy:**

Deposit payment of 50% is required upon scheduling, and the remaining 50% is due on the first day of the rental.

A full refund (100%) is given before one hundred and eighty (180) days of booked date. Fifty percent (50%) refund given within one hundred and seventy nine to fourteen (179-14) days before event. No refund is given if cancellation occurs fourteen (14) days before booked event. One person must be designated the contact person for the event to work with the director of the VEC during the event.
